Website Terms & Conditions of Use

In using our website you are deemed to have read and agreed to the terms and conditions below.

If any provision of these terms and conditions is held to be unlawful, invalid or unenforceable, that provision shall be deemed severed and the validity and enforceability of the remaining provisions of these terms and conditions shall not be affected.

1. Privacy Policy

This privacy policy states how Brockenhurst Parish Council (BPC) will respect the privacy of our website users. It sets out how BPC utilises and protects any information collected whilst using our website.

We are committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified when using this website then you can be assured that it will only be used in accordance with this privacy statement.

This policy is effective from the "Last Updated" date below. We may change this policy from time to time and will flag that we have done so on the home page of our website with a link to the policy page. It is your responsibility to review the revised policy to check that you are happy with any changes.

What type of information do we collect?

We may collect, store and use the following kinds of personal data:

- Information about your computer and about your visits to and use of this website (this may include your IP address, geographical location, browser type, referral source, length of visit and number of page views);
- Contact information which you choose to send to us (such as your name, postal address, email address and telephone number); and
- Any other information you share with us as part of customer surveys, competitions or offers (like preferences and interests).

Cookies

In common with virtually all other websites, BPC and our third party service providers use cookies on our website. A cookie is a small file which asks permission to be placed on your device's hard drive (set using your internet browser settings).

You can choose to accept or decline cookies, however, some of our web applications may not function as intended if the use of cookies is not permitted or enabled. Should you wish to control the use of cookies you can enable and disable them by adjusting your internet browser settings.

Once you agree to accept cookies, a cookie file is saved to your computer and used to store small pieces of data that are sent to your computer when you visit a website. On subsequent visits, this data is then returned to the website to facilitate the tracking of distinct users; helping to analyse web traffic and usage; and to allow website content to be tailored to your needs, preferences and interests.

What do we do with the information we gather?

BPC requires information to better understand our customers' needs and to provide the best services possible. We may use any information collected for:

- Internal record keeping;
- Administration, monitoring and improvement of our website;
- Improvements to your browsing experience by personalising the website and/or linking sessions (to prevent you from having to enter your user name and password each time you request restricted information);
- Enabling your use of the services available on the website;
- Delivery of relevant information and services to you;
- Enabling social sharing of content so you can share useful information easily with your friends or via social media;
- Improving our services;
- Contacting you with regards to any solicitations you have made to us; and
- Periodically sending you emails, with your permission, about new services, plus events, offers and/or other information which we think you might find interesting; and/or
- Dealing with enquiries and complaints made by or about you relating to the website.

We may disclose information about you to any of our employees, members, officers, agents, suppliers or subcontractors insofar as reasonably necessary for the purposes as set out in this privacy policy.

We will not pass on your personal information to any third parties without your express permission except:

- To the extent that we are required to do so by law;
- In connection with any legal proceedings or prospective legal proceedings; and/or
- In order to establish, exercise or defend our legal rights.

Controlling your personal information

We will take reasonable technical and organisational precautions to prevent the loss, misuse or alteration of your personal information and will store all the personal information

you provide on our secure, password and firewall protected network. Please note, however, that data transmission over the internet is inherently insecure and we cannot therefore guarantee the security of data sent by this means.

You may choose to restrict the collection or use of your personal information in the following ways:

- Whenever you are asked to fill in a form on the website, look for the option you can select to indicate that you do not want the information to be used by anybody for direct marketing purposes
- You can also notify us at any time by contacting the Parish Clerk via the website, writing to our postal address or replying to an email sent by us if you no longer wish to receive correspondence from us that you have previously agreed to.

We will not sell or pass on your personal information to any third parties without your express permission unless we are required to do so by law.

You may request details of personal information which we hold about you under the Data Protection Act 1998. If you would like a copy of this information please contact the Parish Clerk by email or by post using the contact details given below.

If you believe that any information we hold about you needs to be corrected or updated then please contact the Parish Clerk as soon as possible and we will take prompt action to amend our records.
