### 18/35 District Councillor's Report

Mrs. Holding reported that NFDC are investigating the purchase of small open-market housing to help to meet the demand from council tenants.

#### 18/36 APM Agenda

The draft agenda was agreed. We have had a suggestion for a speaker on medicine optimisation and we have included him in the agenda subject to confirmation.

#### 18/37 Review of Co-option Policy

The co-option policy needed a small amendment to address the situation where there might be a need to re-run a vote for second place if no clear winner has emerged. This amendment was approved.

### 18/38 Potential commemoration of Indian WWI troops

A letter has been received requesting that a memorial be provided to commemorate the WWI Indian troops in the village. The site in Church Lane was used for Indian troops for a year before it became the NZ Hospital. There is a memorial at Barton-on-Sea and the main memorial is in Brighton. The suggestion that information panels which would inform of the existence of the other memorials, should be investigated, was agreed.

# **18/39 Reports and response to Consultations** - to include ratification of recommendations

Mr. Oram reported on this morning's NPA Development Control meeting, the old Scout Hut application having been withdrawn Mr. Korbey did not attend. It was noted that the development at the old Scout Hut appears not to conform to the permission gained on appeal and discussion is ongoing with the planning department. Enforcement action is being investigated on the land next to the petrol station in Sway Road.

The Non-native species conference held on 1st March was attended by two councillors. There are several invasive species of plant in the Forest. A display at the APM was suggested and this will be progressed. **Action: MC/HM.** 

Mr. Wingham reported on the Personnel and Resources Committee held in early March. All the recommendations were ratified. The Financial Risk Assessment has now been received from the Internal Auditor and was adopted.
